(1) Restricted Stock Units (RSUs) issued in lieu of 2018 annual retainer and committee meeting fees of \$38,500. The RSUs vest ratably on a quarterly basis on the last day of each calendar quarter in 2018, subject to the reporting person's continuous service to Regulus.

(2) 25% of the shares vest on April 14, 2019 and the remainder of the shares vest in equal installments on a monthly basis thereafter, such that the option is fully vested on April 14, 2021, subject to the reporting person's continuous service.
