The shares of common stock of Apache are deemed to also represent certain preferred stock purchase rights ('Rights'). The Rights are not currently exercisable or separately tradable and presently are evidenced by certificates for shares of the common stock. Value attributable to such Rights, if any, is reflected in the market price of the common stock.

(2) Vesting on 12/31/2010 of restricted stock units pursuant to restricted stock unit award agreement under employer plan - data provided by plan administrator on 01/04/2011. Of these 4,000 shares, 2,400 shares (1,525 shares after tax withholding) will not be eligible for sale by the reporting person until such time as he retires or otherwise terminates employment with the company.

(3) Shares withheld to cover required tax withholding on vesting of restricted stock units effective as of 12/31/2010 - data provided by plan administrator on 01/04/2011.

(4) With tandem tax withholding right

(5) Pursuant to a restricted stock unit award agreement dated 11/18/2009, the reporting person was granted 20,000 restricted stock units. The restricted stock units will vest 4,000 on each of 12/31/2010, 11/18/2011, 11/19/2012, 11/18/2013, and 11/18/2014. Upon vesting, Apache will issue one share of common stock for each restricted stock unit, and 2,400 shares out of each 4,000 shares will not be eligible for sale by the reporting person until such time as he retires or otherwise terminates employment with the company.
