Moody's upgrades Petrobras rating

(Rio de Janeiro, August 24, 2007). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA, BCBA: APBR/APBRA], a Brazilian international energy company, announces that the rating agency Moody's Investor Services has raised the foreign currency debt rating of Petrobras and PFICo from Baa2 to Baa1 with a stable outlook.

The upgrade reflects the improvement in the assessment of Brazil, whose local and foreign currency debt rating was raised from Ba2 to Ba1 and whose country ceiling was raised from Ba1 to Baa3 (investment grade), reflecting a moderate risk of default in the event of a government moratorium.

Petrobras Energia S.A.'s US\$ 300 million unsecured Series S notes also obtained an upgrade from Baa2 to Baa1.

The A2 global local currency and the Aaa.br national scale ratings remained unaltered.
