São Paulo, February 27, 2015 - Braskem (BM&FBovespa: BRKM5, BRKM3, BRKM6; NYSE: BAK; LATIBEX: XBRK) hereby announces to its shareholders and the market that it has signed with Petrobras a new amendment to the petrochemical naphtha supply agreement with a 6-month duration, until August 31, 2015. The price will be adjusted retroactively to March 1, 2015, upon the signing of the new agreement.

Braskem will continue to pursue for a structural solution that enables the signing of a new long-term naphtha supply agreement with Petrobras that ensures the competitiveness of the Brazilian chemical and petrochemical industry.
