ITEM 6. OWNERSHIP OF MORE THAN FIVE PERCENT ON BEHALF OF ANOTHER PERSON

First Eagle Investment Management, LLC (FEIM) (Formerly known as Arnhold and S. Bleichroeder Advisers, LLC), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, may be deemed currently to be the beneficial owner of 16,611,083 shares (assuming exercise of warrants to acquire 1,080,115 shares of the Issuer's common stock), or 22.84% of the shares believed to be outstanding, as a result of acting as investment adviser to various clients. Clients of FEIM have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. 21 April Fund, Ltd. ("21 April"), a Cayman Islands company for which FEIM acts as investment adviser, may be deemed to beneficially own 6,495,323 of these 16,611,083 shares (assuming exercise of warrants to acquire 68,250 shares), which equates to 8.48% of the Common Stock. In addition, First Eagle Value in Biotechnology Master Fund, Ltd. ("FEVBM"), a Cayman Islands company for which FEIM acts as investment adviser, may be deemed to beneficially own 5,393,089 of the 16,611,083 shares (assuming exercise of warrants to acquire 70,073 shares), which equates to 7.05% of the Common Stock.
