Item 7.01 Regulation FD Disclosure.

On November 5, 2014, Regency Energy Partners LP (the “Partnership”) and Energy Transfer Partners, L.P. (“ETP”) issued a press release announcing that their joint venture, Lone Star NGL LLC (“Lone Star”), is constructing a third 100,000 barrel per day natural gas liquids (“NGL”) fractionation facility at Mont Belvieu, Texas to handle increasing NGL barrels delivered via Lone Star’s pipeline system.
