(1) Includes 4,500 shares of restricted stock which vest on November 1, 2011.

(2) The number of underlying securities is based on the stock fund balance on February 1, 2010. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a February 1, 2010, stock fund price of \$28.73 per share.

(3) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock.

(4) Consists of an award of 6,500 restricted stock units granted on November 2, 2009, which vest as follows: 3,250 units on November 2, 2011, and 3,250 units on November 2, 2013. The phantom stock units representing the award and the dividends which accrue during the restrictive period are to be settled 100% in cash, pending vesting.

(5) The restricted stock units represent the reinvestment of dividends which are accruing under the Johnson Controls deferred Restricted Stock Plan and are to be settled 100% in cash upon the vesting of the restricted stock grant to which they relate.

(6) Shares of phantom stock are payable in cash following the reporting person's termination of employment with the issuer and may be transferred by the reporting person into an alternative investment account at any time.

(7) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
