## ITEM 4.02 NON-RELIANCE ON PREVIOUSLY ISSUED FINANCIAL STATEMENTS OR A RELATED AUDIT REPORT OR COMPLETED INTERIM REVIEW

(a)

On November 4, 2015, the audit committee of the board of directors of each of Hertz Global Holdings, Inc. (“Hertz Global”) and The Hertz Corporation (together with Hertz Global, “Hertz” or the “Company”), in consultation with management and after discussion with PricewaterhouseCoopers LLP, the Company's independent registered accounting firm, determined that the Company's previously issued condensed consolidated financial statements for the three months ended June 30, 2015 should no longer be relied upon because of errors related to the depreciation of vehicles sold through our retail locations and other immaterial adjustments. As a result of these errors, the Company's income (loss) before income taxes and net income (loss) were understated by \$21 million and \$13 million, respectively, for the three and six months ended June 30, 2015. The Company has determined it must restate the condensed financial statements for the three and six months ended June 30, 2015 and has filed an amendment to the Company's Form 10-Q for the three months ended June 30, 2015 filed on August 10, 2015.

Hertz Global is providing additional financial information with respect to the fiscal years ending December 31, 2014 and 2013 and the periods ending June 30, 2015 (Restated) and March 31, 2015 in the document attached as Exhibit 99.2 to this current report. This financial information includes certain non-GAAP financial measures that are detailed in Exhibit 99.2.

On November 9, 2015, the Company will conduct an earnings webcast relating to the Company's financial results for the three months ended September 30, 2015. The earnings webcast will be made available to the public via a link on the Investor Relations section of the Hertz website, IR.Hertz.com and the slides that accompanied the presentation will be available to the public at the time of the earnings webcast through the Company's website. Certain financial information relating to completed fiscal periods that will be part of the earnings webcast is included in the set of slides that will accompany the earnings webcast, a copy of which is attached hereto as Exhibit 99.3. The earnings webcast will include certain non-GAAP financial measures. Reconciliations of these non-GAAP financial measures to the comparable measures calculated and presented in accordance with GAAP are attached hereto as part of Exhibit 99.3.
