**Entry into a Material Definitive Agreement**

As previously reported by CareView Communications, Inc. (the "Company") in its Current Report on Form 8-K filed with the Securities and Exchange Commission (the "SEC") on April 27, 2011, we entered into a Note and Warrant Purchase Agreement dated April 21, 2011 (the "Purchase Agreement") with HealthCor Partners Fund, LP ("HealthCor Partners") and HealthCor Hybrid Offshore Master Fund, LP ("HealthCor Hybrid" and, together with HealthCor Partners, the "HealthCor Parties"). As previously reported in the Company's Current Report on Form 8-K filed with the SEC on December 19, 2014, on December 15, 2014, we entered into a Fifth Amendment to Note and Warrant Purchase Agreement (the "Fifth Amendment") with the HealthCor Parties and certain additional investors party thereto (such additional investors, the "New Investors" and, collectively with the HealthCor Parties, the "Investors"). On January 7, 2015, the Company and the Investors mutually agreed to reschedule the closing date of the transaction contemplated by the Fifth Amendment to January 28, 2015, or such earlier date as the Company and the Investors may agree, subject to the satisfaction or waiver of the closing conditions under the Fifth Amendment. The information called for by this item that is contained in Item 2.03 of the Company's Current Report on Form 8-K filed with the SEC on December 19, 2014 is incorporated herein by reference.
