- (1) Between February 13, 2009 and April 3, 2009, the Reporting Person acquired 217 shares of DRE common stock through dividend reinvestment.

- (3) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/30/2007.
- (4) The Stock Options vested annually at a rate of 20% per year and were fully vested on 1/29/2008.

(6) Represents phantom stock units accrued under the Directors' Deferred Compensation Plan of Duke Realty Corporation. The units are valued on a one to one basis to the Company's common stock and are to be settled in cash and stock upon the Reporting Person's termination as a director of the Issuer.
