- (1) The sale was made pursuant to a Rule 10b5-1 Sales Plan adopted by the Reporting Person on June 11, 2013.
The 20,000 shares were sold in 9 lots ranging from 82 shares to 6,078 shares per lot. The sale price ranged between \$31.32 and \$31.40.
