(1) The shares were issued to the Reporting Person in accordance with the merger agreement entered into by and among the Issuer, Banc of California, N.A., CS Financial, Inc. ("CS Financial") and the other parties named thereto, dated October 25, 2013 (the "CS Merger Agreement"), wherein the Issuer acquired all outstanding shares of CS Financial in exchange for cash and shares of the Issuer's common stock. Prior to the completion of the merger transaction contemplated under the CS Merger Agreement, which transaction was completed on October 31, 2014 (the "Merger"), the Reporting Person was the majority owner of CS Financial, and the shares reported herein were issued as a portion of the consideration for the Reporting Person's interest in CS Financial.

(2) Includes 31,600 shares held by CS Financial prior to the Merger, which shares are now directly held by the Reporting Person.
