- (1) On March 2, 2010, four business days following the release of the Company's 2009 Earnings, vesting conditions for 5,227 performance-based RSUs awarded in 2009 were met, resulting in the immediate issuance of equivalent shares of Common Stock which became reportable for Section 16 purposes. 1,906 were withheld shares in payment of tax obligations from the total of 5,227 shares issuable, resulting in the net amount of shares reported above.
