- (3) Options become exercisable in 25% increments on the first, second, third and fourth anniversary dates of the grant.

If McDonald's Corporation satisfies both the EPS and ROIIC thresholds, then the number of RSUs that vest may be increased or decreased based upon the McDonald's Corporation total shareholder return relative to the S&P 500 Index over the

Performance Period. The number of RSUs earned will range from 0% to 200% of the target number of RSUs granted.
