[1] The title of the securities underlying the American Depository Shares is Common Stock,

par value (Won)5,000 per share. The securities covered by this Schedule 13G may include

Common Stock and American Depository Shares. The CUSIP reported is the CUSIP for the

American Depository Shares.

[2] Franklin Templeton Portfolio Advisors, Inc. ("FTPA") may beneficially own these securities

pursuant to various separately managed account investment management arrangements. Under

these arrangements, underlying clients may, from time to time, delegate to FTPA the power

to vote such securities, in which case FTPA has sole voting power. To the extent that the

underlying client retains voting power over any securities, FTPA disclaims any power to

vote or direct the vote of such securities.

[3] One or more of the investment management contracts that relates to these securities provides

that the applicable FRI affiliate share investment power over the securities held in the

client's account covered by such contract with another unaffiliated entity. The issuer's

securities held in all such accounts are less than 5% of the outstanding shares of the

class. In addition, FRI does not believe that any such contract causes such client or any

such unaffiliated entity to be part of a group with FRI or any FRI affiliate within the

meaning of Rule 13d 5 under the Act.
