On August 5, 2004, the Registrant issued a press release reporting its sales and net income for its fourth quarter and year ended May 29, 2004 and announcing the declaration of a cash dividend. The Registrant also filed a Current Report on Form 8-K in connection with this press release. This amendment is being filed to correct a computational error in the press release. The error was contained in the results of Continuing Operations and Discontinued Operations for the fourth quarter of fiscal 2003 which were used in the comparison of the results of Continuing Operations and Discontinued Operations for the fourth quarter of fiscal 2004 with the results of Continuing Operations and Discontinued Operations for the fourth quarter of fiscal 2003. As corrected, the Net Income from Continuing Operations for the fourth quarter of fiscal 2003 ended May 31, 2003 was \$3.1 million, or \$0.07 per share, and the Net Loss from Discontinued Operations for the fourth quarter of fiscal 2003 ended May 31, 2003 was \$0.4 million, or \$0.01 per share.
