- (1) The amount of the phantom stock units previously reported was 185 shares, but was adjusted to reflect the 2-for-1 stock split that occurred with respect to the Issuer's common stock on June 9, 2006. - (2) In connection with this transaction, the reporting person acquired 18 stock credits resulting from a dividend reinvestment feature of the directors' compensation program. Those shares were settled in cash at the same \$17.98 per share price, or \$323.64.
