The Company has now commenced the process of repairing the damage incurred by the ATWOOD BEACON on July 25, 2004. Repairs have commenced on the drilling unit at the builder's shipyard in Singapore. One of the three legs has been recovered and is in the process of being transported to Singapore. Until the other two legs have been recovered, transported to Singapore and inspected, which is estimated to be around mid-September 2004, the Company will not be able to determine the repair period for the rig. The ATWOOD BEACON has been awarded a contract for a drilling program in Vietnam which must be commenced between January 15, 2005 and April 15, 2005. A copy of the press release announcing this contract award is filed with this Form 8-K as Exhibit EX-9.1.

Additional information with respect to the Company's Contract Status Summary at August 31, 2004 is attached hereto as Exhibit EX-9.2 which is being furnished in accordance with Rule 101(e)(1) under Regulation FD and should not be deemed to be filed.

ITEM 8.01 OTHER EVENTS

On September 1, 2004 the Company announced that the ATWOOD BEACON was awarded a contract to drill three firm wells, with options to drill three additional wells, offshore Vietnam. This drilling program must commence between January 15, 2005 and April 15, 2005. A copy of the press release announcing the contract award is filed with this Form 8-K as Exhibit EX-9.1 and is incorporated herein by reference.

ATWOOD OCEANICS ANNOUNCES CONTRACT FOR ATWOOD BEACON

Houston, Texas
1 September 2004

FOR IMMEDIATE RELEASE

Atwood Oceanics, Inc. (Houston-based International Offshore Drilling Contractor - NYSE: ATW) announced today that HOANG LONG and HOAN VU Joint Operating Companies have awarded a contract to the ATWOOD BEACON to drill three (3) firm wells, with options to drill three (3) additional wells, offshore Vietnam. This contract provides for a dayrate of \$62,000 for the three firm wells, a dayrate of \$77,000 for the three option wells, and payment of \$58,000 per day plus the cost of a tow vessel and fuel to mobilize the rig from Singapore to Vietnam. The three firm wells have a combined expected duration of 200 days and if all three option wells are drilled, the program could extend for another 200 days. The drilling of this program must commence between January 15, 2005 and April 15, 2005.

ATWOOD SOUTHERN CROSS MALAYSIA MURPHY SARAWAK OIL COMPANY, LTD. ("MURPHY")

In March 2004, the rig commenced a drilling program which now includes 10 wells plus options to drill 10 more wells. The rig has been awarded a contract by International Corporation to drill 10 wells plus an option to drill 10 more wells offshore Myanmar. The rig commenced drilling immediately after completion of the drilling of the two firm wells. It is expected to take 80 to 90 days to complete.

SEASCOUT UNITED STATES GULF OF MEXICO

The SEASCOUT was purchased by the company for conversion to a tender-assisted rig. The SEASCOUT is currently coldstacked in the Gulf of Mexico.

THAILAND CHEVRON OFFSHORE (THAILAND) LIMITED ("CHEVRON")

In May 2004 the rig's contract with Chevron Exploration & Production Company was suspended and the rig moved to coldstack. The rig is expected to be redeployed in a drilling program for Chevron in the Gulf of Thailand. The rig is expected to extend into October 2004. The rig will be moved back to the Gulf of Thailand will reinstate the rig's contract. Upon reinstatement, the EMEPMI contract will include the estimated five months plus an extension of twelve months plus an extension of twelve months commencing in July 2004. EMEPMI recommences its contract with Chevron right to terminate the contract with 90 days notice.

ATWOOD BEACON UNDER REPAIR AT A SINGAPORE SHIPYARD

The process of repairing ATWOOD BEACON on July 25, 2004. Repairs have commenced on the rig at the shipyard in Singapore. The rig's legs has been recovered and the rig has been transported to Singapore. The rig's legs have been recovered, transported to Singapore, inspected, which is estimated to take 30 days. In mid-September 2004, the rig will be moved back to the Gulf of Thailand to determine the repair period. The rig BEACON has been awarded a contract by HOAN VU Joint Operating Company to drill 10 wells, with options to drill 10 more wells offshore Vietnam. The rig is expected to commence drilling combined expected duration of 100 days. The rig option wells are drilled, which is expected to take another 200 days. The rig is expected to commence drilling between January and February 2005.
