Pursuant to a Subadvisory Agreement with SP13, in certain circumstances SP13 has the right to override the voting decisions made by JANA Partners LLC with respect to securities held in SP13, including 82,628 shares of Common Stock, and has the right to terminate its Subadvisory Agreement with JANA Partners LLC. The principals of JANA Partners LLC, Barry Rosenstein and Gary Claar, are U.S. citizens.
