The warrant, which was initially issued for 14,167 shares of the Issuer's Series A Preferred Stock at an exercise price of \$10.00 per share, currently represents a warrant for 12,997 shares of the Issuer's Common Stock at an exercise price of \$10.90 per share. The revised (1) warrant terms reflect (i) the conversion of the Series A Convertible Preferred Stock into Common Stock at a conversion ratio of 2.276012305 to 1, which conversion occurred automatically on December 13, 2006 in connection with the Issuer's initial public offering and (ii) the 1-for-2.4808 reverse split of the Issuer's Common Stock effective December 19, 2006.
