Components

Haifa, Israel, June 13, 2012 – Elbit Systems Ltd. (NASDAQ and TASE: ESLT) (“Elbit Systems”) announced today that its wholly-owned Israeli subsidiary Elbit Systems – Cyclone Ltd. (“Cyclone”) was awarded an approximately \$80 million contract for the supply of structural components to The Boeing Company (“Boeing”). The contract will be performed over seven years.

Yoram Shmueli, Co-General Manager of Elbit Systems’ Aerospace Division, commented: “We are proud to have been selected, once again, by Boeing to supply structural parts. This contract represents another step in positioning Cyclone as a major supplier to leading aerospace companies and other customers. We believe this contract with Boeing will pave the way for further business in the fast-growing aerostructures market, characterized by advanced technologies and innovative composite materials.”
