By reason of its position as general partner of MP, MHF, and MHFII, Holdings may be deemed to beneficially own the 22,600 shares owned by MP, the 91,100 shares owned by MHF, and the 519,200 shares owned by MHFII or an aggregate of 632,900 shares of Common Stock, constituting approximately 2.82% of the shares outstanding.
- Mr. Maltese directly owned no shares of Common Stock.
