(1) Reflects a stock dividend declared on March 18, 2004, of .05 shares of Class A Common Stock per outstanding share of Class A Common Stock and .05 shares of Class B Common Stock per outstanding share of Class B Common Stock, paid to holders of record on March 30, 2004.

(2) Includes 25,475 shares of Class B Common Stock held by the reporting person and 1,029 shares of Class B Common Stock held in the Issuer's 401(k) plan. Class B Common Stock is immediately convertible into Class A Common Stock on a one share for one share basis. Also includes 1,544.01 shares of Class A Common Stock allocated to the reporting person under the Republic Bancorp, Inc. Employee Stock Ownership Plan (the "ESOP"), and 23,922 shares of Class A Common Stock held in the Issuer's 401(k) plan. Does not include an undetermined number of shares of Class A Common Stock to be allocated to the reporting person under the ESOP as of December 31, 2004, for which the reporting person has not yet received a plan statement.

(3) Includes 6,198,792 shares of Class A Common Stock held of record by Teebank, 802,183 shares of Class B Common Stock held of record by Teebank, 647,938 shares of Class A Common Stock held of record by Jaytee, and 145,182 shares of Class B Common Stock held of record by Jaytee. The reporting person is a limited partner of Teebank and Jaytee. The reporting person shares voting power over the shares held of record by Teebank and Jaytee with Steven E. Trager and Sheldon Gilman, as trustee.

(4) Includes 17,751 shares of Class A Common Stock and 3,549 shares of Class B Common Stock held by a family trust of which the reporting person is a co-trustee and a beneficiary.

Trager and Sheldon Gilman as trustee (each a beneficial owner of more than five percent of the class), among others, are limited partners of Teebank and Jaytee, and thereby possess the right to receive dividends from or the proceeds from the sale of pro rata interests in the Issuer's securities upon distribution of assets from Teebank and Jaytee.
