- (1) Represents 250,000 shares of restricted stock granted on September 14, 2010 pursuant to the APAC Customer Services, Inc. Amended and Restated 2005 Incentive Stock Plan. Subject to a change in control of the Issuer, such restricted stock will vest over a five year period pro rata. The vesting for the restricted stock may be accelerated on the second and third anniversary of the grant based on the Company meeting specific performance goals.
- (2) Stock option grant pursuant to the APAC Customer Services, Inc. 2005 Amended and Restated Incentive Stock Plan. Subject to a change in control of the Issuer, the options vest in five equal annual installments beginning on the first anniversary of the grant date, and expire 10 years from the grant date, unless earlier terminated pursuant to the terms of the Plan. The options include the right of the Reporting Person to surrender shares to the Issuer in order to pay the exercise price of an option.
