## **Syngenta and Sumitomo enter herbicide license agreement**

**Basel, Switzerland, 8 February 2005**

Syngenta announced today that it has entered a licensing agreement with Sumitomo Chemical from Japan for the development and marketing of a new herbicide. This agreement provides Syngenta with full, worldwide rights to the herbicide SYN 523, which Syngenta will continue to develop to further strengthen its portfolio. Sumitomo Chemical will receive royalty payments as well as distribution rights to certain products in specific countries.

The new herbicide promises to give exceptionally broad-spectrum weed control. First products will be several years in development and registration, with the first launch expected within five to seven years.

Further details of the agreement were not disclosed.

Syngenta is a world-leading agribusiness committed to sustainable agriculture through innovative research and technology. The company is a leader in crop protection, and ranks third in the high-value commercial seeds market. Sales in 2003 were approximately \$6.6 billion. Syngenta employs some 19,000 people in over 90 countries. Syngenta is listed on the Swiss stock exchange (SYNN) and in New York (SYT).
