INFORMATION REQUIRED IN REGISTRATION STATEMENT

The Registrant filed with the Securities and Exchange Commission (the “Commission”) on April 8, 2005 a Registration Statement on Form F-3 (the “Registration Statement”) relating to the Registrant’s Debt Securities and Dollar Preference Shares. The Registration Statement was declared effective by the Commission on April 25, 2005. On June 20, 2007, the Registrant filed with the Commission pursuant to Rule 424(b)(3) under the Securities Act of 1933, as amended, a prospectus dated June 20, 2007 and a preliminary prospectus supplement dated June 20, 2007. On June 26, 2007, the Registrant filed with the Commission pursuant to Rule 424(b)(2) under the Securities Act of 1933, as amended, a prospectus dated June 20, 2007 and final prospectus supplement dated June 22, 2007 (the “Prospectus” and “Prospectus Supplement”, respectively). The Prospectus Supplement and the Prospectus are incorporated herein by reference to the extent set forth below.
