Further to the information released on April 15th, 2011 and pursuant to the resolution adopted by the Board of Directors of TELEFÓNICA, S.A., the Company will pay on May 6th, 2011, an interim dividend from 2011 net income, of a fixed gross amount of 0.75 euro for each Company share issued, in circulation and carrying entitlement to this dividend (Record Date: Thursday, May 5th, 2011).
