To the Editors:

Your article today, headlined "Hughes Considers News Corp. Deal," incorrectly states that senior Hughes officials are "revving up discussion of potential regional collaboration or outright merger" with News Corporation's Latin American broadcasting interests.

To set the record straight, at this time there are no discussions or negotiations regarding a merger or sale of DIRECTV Latin America. We are, however, continuing to work aggressively to achieve approval of our merger with EchoStar.

The article also has taken out of context something I said yesterday during a conference call for analysts. During the call, in reference to our current plans for DIRECTV Latin America, I said "we are going to hunker down, conserve cash, and weather the storm until the macro environment turns around." Your article used the "hunker down, conserve cash" portion of my statement, but then went on to imply that we are trying to "figure out an exit strategy."

It is not appropriate for me to discuss in detail our thinking or planning regarding the future of DIRECTV Latin America. I will say, however, that we are working hard on a solid action plan that we believe will stem the losses of this business and position it for growth and success in the future. DIRECTV Latin America is the largest pay television provider in the region, and a valuable asset. Despite the current economic challenges in Latin America, the business has the potential for success.

Exchange Commission ("SEC"), including a Registration Statement of Hughes Holdings on Form S-4 that contains a consent solicitation statement/information statement/prospectus. These materials are not yet final and will be further amended. Holders of GM \$1-2/3 and GM Class H common stock are urged to read the definitive versions of these materials, as well as any other relevant documents filed or that will be filed with the SEC, as they become available, because these documents contain or will contain important information. The preliminary materials, the definitive versions of these materials and other relevant materials (when they become available), and any other documents filed by GM, Hughes Electronics Corporation ("Hughes"), Hughes Holdings or EchoStar with the SEC may be obtained for free at the SEC's website, www.sec.gov, and GM stockholders will receive information at an appropriate time on how to obtain transaction-related documents for free from GM.

GM and its directors and executive officers, Hughes and certain of its officers, and EchoStar and certain of its executive officers may be deemed to be participants in GM's solicitation of consents from the holders of GM \$1-2/3 common stock and GM Class H common stock in connection with the proposed transactions. Information regarding the participants and their interests in the solicitation was filed pursuant to Rule 425 with the SEC by EchoStar on November 1, 2001 and by each of GM and Hughes on November 16, 2001. Investors may obtain additional information regarding the interests of the participants by reading the amended preliminary consent solicitation statement/information statement/prospectus filed with the SEC and the definitive consent solicitation statement/information statement/prospectus when it becomes available.

This communication shall not constitute an offer to sell or the solicitation of an offer to buy, nor shall there be any sale of securities in any jurisdiction in which such offer, solicitation or sale would be unlawful prior to registration or qualification under the securities laws of any such jurisdiction. No offering of securities shall be made except by means of a prospectus meeting the requirements of Section 10 of the Securities Act of 1933, as amended.

You are urged to consider statements that include the words "may," "will," "would," "could," "should," "believes," "estimates," "projects," "potential," "expects," "plans," "anticipates," "intends," "continues," "forecast," "designed," "goal," or the negative of those words or other comparable words to be uncertain and forward-looking. This cautionary statement applies to all forward-looking statements included in this document.
