This Amendment No. 1 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Sapling, LLC, a Delaware limited liability company ("Sapling"), Fir Tree Recovery Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Recovery") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock, par value \$0.0001 (the "Common Stock") of RAM Energy Resources, Inc., a Delaware corporation (the "Issuer"), purchased by Sapling and Fir Tree Recovery. Fir Tree Value Master Fund, LP, a Cayman Islands exempted limited partnership ("Fir Tree Value"), is the sole member of Sapling, and Fir Tree is the investment manager of both Sapling and Fir Tree Recovery.

Collectively, the Reporting Persons beneficially own 0 shares of Common Stock which represent 0% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares beneficially held by 33,531,900 the number of shares of Common Stock issued and outstanding as of August 11, 2006 as reported in the Issuer's Form 10-Q/A filed with the Securities and Exchange Commission on December 20, 2006.
