#### INSIGNIA FINANCIAL GROUP, INC. TELEPHONE PROXY VOTING SCRIPT JUNE 25, 2003

"WELCOME TO THE TELEPHONE PROXY VOTING SYSTEM FOR THE SPECIAL MEETING OF STOCKHOLDERS OF INSIGNIA FINANCIAL GROUP. TO AUTHORIZE THE NAMED PROXIES TO VOTE ON YOUR BEHALF, PLEASE ENTER THE CONTROL NUMBER ON YOUR CARD, FOLLOWED BY THE POUND SIGN."

If control number is validated, then:

"TO VOTE AS THE BOARD OF DIRECTORS RECOMMENDS ON THE MERGER PROPOSAL, PRESS 1. OTHERWISE, PRESS 2."

If 1, then: (recap and confirmation routine)

"YOU HAVE CHOSEN TO VOTE AS THE BOARD OF DIRECTORS RECOMMENDS ON THE MERGER PROPOSAL. TO CONFIRM YOUR VOTE, PRESS 1. TO CHANGE YOUR VOTE PRESS 2."

If 2, the process starts again from the top. If 1, then (signoff):

"YOUR VOTE HAS BEEN CAST. IF YOU WOULD LIKE TO VOTE ANOTHER PROXY CARD FOR THIS COMPANY, PRESS 1. IF NOT, YOU MAY HANG UP NOW. THANK YOU FOR YOUR CALL."

If 2 (election to vote on each proposal separately). then:

"TO CAST YOUR VOTE REGARDING THE MERGER PROPOSAL, PRESS 1 TO VOTE IN FAVOR, PRESS 2 TO VOTE AGAINST, OR PRESS 3 TO ABSTAIN."

Vote recap and confirmation routine.

When last proposal is confirmed, then (signoff):

"YOUR VOTE HAS BEEN CAST. IF YOU WOULD LIKE TO VOTE ANOTHER PROXY CARD FOR THIS COMPANY, PRESS 1. IF NOT, YOU MAY HANG UP NOW. THANK YOU FOR YOUR CALL."
