**FLOATING RATE CONVERTIBLE SENIOR DEBENTURES DUE DECEMBER, 2035**

This prospectus supplement updates and amends certain information contained in the prospectus dated March 10, 2006, as supplemented by a prospectus supplement dated April 13, 2006, by prospectus supplement No. 2 dated July 13, 2006, by prospectus supplement No. 3 dated October 13, 2006, by prospectus supplement No. 4 dated January 12, 2007, by prospectus supplement No. 5 dated April 12, 2007, by prospectus supplement No. 6 dated July 13, 2007 and by prospectus supplement No. 7 dated October 11, 2007, relating to the offer and sale from time to time by certain selling securityholders of up to \$2,000,000,000 aggregate principal amount of our Floating Rate Convertible Senior Debentures due December, 2035 and any shares of common stock issuable upon conversion of the debentures. The terms of the debentures are set forth in the prospectus and any supplements or amendments thereto. This prospectus supplement should be read in conjunction with, and may not be delivered or utilized without, the prospectus, the prospectus supplement dated April 13, 2006, and any amendments or supplements thereto. This prospectus supplement is qualified by reference to the prospectus, the prospectus supplement dated April 13, 2006, and any amendments or supplements thereto, except to the extent that the information in this prospectus supplement supersedes the information contained in the prospectus, the prospectus supplement dated April 13, 2006, or in any amendments or supplements thereto. The terms of the debentures are set forth in the prospectus and the prospectus supplement dated April 13, 2006.

As a result, the amount of common stock issuable upon conversion of the debentures may increase or decrease in the future.
- (2) Assumes that all of the debentures and/or all of the common stock into which the debentures are convertible are sold. No selling securityholder will own more than 1% of our outstanding common stock after the offering by such securityholder.

None of the named selling securityholders nor any of their affiliates, officers, directors or principal equity holders has held any position or office or has had any material relationship with us within the past three years.
