On December 3, 2013, China XD Plastics Company Limited (the "Company") held its 2013 Annual Meeting of Stockholders (the "Annual Meeting"), for the purpose of: (i) electing eight (8) directors and (ii) ratifying the appointment of KPMG as the Company's independent registered certified public accountant for the fiscal year ending December 31, 2013. For more information on the proposals described below, please refer to the Company's proxy statement dated November 20, 2013.

As of November 11, 2013, the record date for the Annual Meeting, there were a total of 47,868,772 shares of common stock, par value \$0.0001 per share (the "Common Stock"), 1,000,000 shares of series B preferred stock, par value \$0.0001 per share (the "Series B Preferred Stock"), and 16,000,000 shares of series D preferred stock, par value \$0.0001 per share (the "Series D Preferred Stock") issued and outstanding and entitled to vote at the Annual Meeting. At the Annual Meeting, 36,572,627 shares of Common Stock, 1,000,000 shares of Series B Preferred Stock, and 16,000,000 shares of Series D Preferred Stock, collectively representing an approximately 89.39% of the combined voting power of all classes of stock entitled to vote, were represented in person or by proxy, and therefore a quorum was present.

The voting results for each of the proposals voted upon are as follows:

#### Proposal 1 — Election of Directors

The eight (8) nominees proposed by the Board of Directors were elected to serve as directors until the Company's Annual Meeting of Stockholders to be held in 2014 and until each director's successor is duly elected and qualified. The voting results for each nominee were as follows:
