**Explanatory Statement**

On March 21, 2002, UTStarcom, Inc. (the Company ) filed a Registration Statement on Form S-8 (File No. 333-84710) (the Registration Statement ), which registered (i) 1,200,000 shares of the Company s common stock, par value \$0.00125 per share ( Common Stock ), reserved for issuance under the Company s 2001 Director Option Plan (the 2001 Plan ), (ii) 4,372,167 shares of Common Stock reserved for issuance under the Company s 1997 Stock Plan (the 1997 Plan ), and (iii) 208,594 shares of Common Stock reserved for issuance under the Advanced Communication Devices Corporation Incentive Program (the ACD Plan ).

All shares of Common Stock originally issuable under the 2001 Plan and the 1997 Plan that were registered under the Registration Statement and that are otherwise available for issuance thereunder will now be issued pursuant to the Company s 2006 Equity Incentive Plan (such shares, the Deregistered Shares ), and this Post-Effective Amendment No. 1 to the Registration Statement is being filed to deregister the Deregistered Shares. Accordingly, the Company hereby deregisters the Deregistered Shares.

The shares of Common Stock registered for issuance under the ACD Plan are not being deregistered and remain subject to issuance thereunder.
