**Moscow, Russian Federation** MTS PJSC ( MTS or the Company NYSE: MBT; MOEX: MTSS), the leading telecommunications provider in Russia and the CIS, notes that Sistema PJSFC (LSE: SSA, MOEX: AFKS), the parent company of MTS with effective ownership stake in MTS of 50.004%, received a legal claim filed by Rosneft PJSC and Bashneft PJSOC against Sistema PJSFC and its subsidiary Sistema-Invest JSC for the recovery of damages in the amount of RUB 131,639,012,421.
