Evaluation of Disclosure Controls and Procedures

TransAlta has designed disclosure controls and procedures to ensure that material information relating to the Company, including its consolidated subsidiaries, is made known to the Chief Executive Officer and Chief Financial Officer by others within the Company, including its consolidated subsidiaries, on a regular basis, in particular during the period in which its Current Reports on Form 6-K relating to quarterly financial results are being prepared. TransAlta to issue US\$300 million of senior notes

CALGARY, Alberta (Nov. 18, 2003) - TransAlta Corporation (TSX: TA; NYSE: TAC) announced today the pricing of an underwritten offering in the United States of US\$300 million of 10-year senior notes. The notes bear interest at a rate of 5.75 per cent and mature on Dec. 15, 2013. Closing is scheduled to occur on Nov. 25, 2003.

The Corporation's unsecured long-term debt, which includes the notes, has been rated Baa2 by Moody's Investor Service, Inc. and BBB- by Standard & Poor's Rating Services.

Net proceeds from the offering will be used for general corporate purposes, including the repayment of indebtedness and the financing of the Corporation's long-term investment plan.

The underwriters are led by Citigroup and Merrill Lynch & Co., the joint book-running managers for the offering. The notes are being sold only through a prospectus supplement to TransAlta's previously filed US\$1.0 billion shelf registration statement dated May 14, 2002 with the U.S. Securities and Exchange Commission.

With approximately 10,000 megawatts of capacity either in operation, under construction or in development, our focus is to efficiently operate our assets in order to provide our wholesale customers with a reliable, low-cost source of power.
