(1) Annual grant of restricted stock units (RSUs) to non-employee directors granted under the 2006 Equity Incentive Plan, representing a contingent right to receive shares of common stock. RSUs vest one-third on the earlier to occur of March 4, 2009 or the 2009 ABM Annual Meeting of Shareholders; one-third on the earlier to occur of March 4, 2010 or the 2010 Annual Meeting of Shareholders; and one-third on the earlier to occur of March 4, 2011 or the 2011 Annual Meeting of Shareholders.

(2) Includes 4,996 RSUs and 882 shares of common stock that reflect the settlement of one-third of March 6, 2007 RSU grant.
