Dividend equivalent rights will accrue.
 - (2) Includes 7,586 unvested RSUs and 8,244 vested RSUs, the receipt of which has been deferred, and DERs relating to the unvested and vested RSUs, adjusted to reflect the cumulative effect of fractional shares.
