This programme is part of the overall share repurchase programme of up to DKK

17.5 billion to be executed during a 12-month period beginning 30 January 2015.

Under the programme initiated 30 April 2015, Novo Nordisk will repurchase B shares for an amount up to DKK 9.3 billion in the period from 30 April 2015 to 27 October 2015.

With the transactions stated above, Novo Nordisk owns a total of 27,609,691 B shares of DKK 0.20, corresponding to 1.1% of the share capital, as treasury shares. The total amount of A and B shares in the company is 2,600,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 17.5 billion during a 12-month period beginning 30 January 2015. As of 30 June 2015, Novo Nordisk has repurchased a total of 18,997,904 B shares equal to a transaction value of DKK 6,643,415,858.
