- (1) On February 8, 2018, the Company effected a 2-for-1 stock split. The number of shares reported in this Form 4 has been adjusted to reflect the stock split.
- (2) Each Restricted Stock Unit represents a contingent right to receive one share of Simmons First National Corporation common stock. 25% Restricted Stock Units vest upon acceptance of the grant; 25% Restricted Stock Units vest on July 2, 2018; 25% Restricted Stock Units vest on October 1, 2018 and 25% Restricted Stock Units vest on January 2, 2019. SFNC shares will be delivered within 30 days of vesting. Events such as retirement, death, disability and other specified events in the agreement may result in earlier vesting.
