(4) As previously reported, on 01/15/09 the reporting person was granted 6,020 restricted stock units ("RSUs"), 3,010 of which vested on 01/15/10, and 3,010 of which will vest on 01/15/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock. The number of derivative securities beneficially owned in column 9 includes 4.5187 dividend equivalent rights at \$53.29 per RSU credited to the reporting person's account on 04/07/10.

(5) As previously reported, on 12/10/09 the Reporting Person was granted 6,020 restricted stock units ("RSUs"), 3,010 of which will vest on 12/10/10 and 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
