The Certificate of Designations of the Series B Convertible Preferred Stock provides that, upon optional conversion, accrued but unpaid dividends convert into common stock at (1) the initial issuance price of \$6.00 per share, subject to certain anti-dilution adjustments, none of which have occurred. As of June 8, 2006, accrued and unpaid dividends on the Series B Convertible Preferred Stock held by the Reporting Person amounted to 25 shares of common stock.
