The reporting person will receive a proportionate amount of such shares if she retires, dies or is disabled prior to January 28,
- (1) 2011. The reporting person has elected to defer receipt of these shares under the Cleco Corporation Deferred Compensation Plan (the "Plan"). Each share of phantom stock is the economic equivalent of one share of Cleco Corporation common stock. Shares of phantom stock may be transferred by the reporting person into an alternative investment account at any time pursuant to the terms and provisions of the Plan.
