Unilever NV announces that on 4 May 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 23.341 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 312,410 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 63,985,948 Unilever NV ordinary shares in treasury, and has 1,650,741,752 Unilever NV ordinary shares in issue (excluding treasury shares).
