Item 7.01 Regulation FD Disclosure.

On October 31, 2005, CSX Corporation announced the results of the October 30, 2005 purchase option under its Zero Coupon Convertible Debentures due October 30, 2021. CSX purchased \$4,000.00 aggregate principal amount at maturity of the debentures, which had been validly tendered and not withdrawn as of the close of business on October 27, 2005, for an aggregate cash consideration of \$3,409.92. As a result, \$548,179,000 aggregate principal amount at maturity of the debentures remain outstanding.
