(d) On September 18, 2008, Jay O. Light was appointed to the board of directors of Blackstone Group Management L.L.C., the general partner (the General Partner) of The Blackstone Group L.P. (the Partnership).

Mr. Light will receive an annual cash retainer of \$100,000. In addition, Mr. Light received upon his appointment a grant of 15,000 deferred restricted common units under the Partnership's 2007 Equity Incentive Plan. These deferred restricted common units will vest, and the underlying common units will be delivered, in equal installments on each of the first, second and third anniversaries of the date of grant, subject to such director's continued service on the board of directors of the General Partner.
