#### Item 8.01. Other Events

On April 13, 2012, in connection with its proposed acquisition of Convio, Inc., a Delaware corporation, Blackbaud, Inc. refiled its Premerger Notification and Report Form with the Department of Justice (the DOJ) and Federal Trade Commission (the FTC) under the Hart-Scott-Rodino Antitrust Improvements Act of 1976 (the HSR Act). The waiting period under the HSR Act, which began upon refiling, is scheduled to expire at 11:59 p.m., New York City time, on April 30, 2012, unless earlier terminated by the FTC and the DOJ or Blackbaud receives a request for additional information that would extend the waiting period. A copy of the press release Blackbaud issued in this regard is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
