This Amendment No. 1 (Amendment No. 1) amends and supplements the Tender Offer Statement on the Schedule TO initially filed with the Securities and Exchange Commission (the SEC) on August 8, 2017 by MFS Investment Grade Municipal Trust, a closed-end management investment company (the Fund) in connection with the Funds offer to purchase for cash up to 15% or 1,738,044 shares of its outstanding common shares, without par value, upon the terms and subject to the conditions set forth in the Funds Offer to Purchase dated August 8, 2017 (the Offer to Purchase) and the related Letter of Transmittal (the Letter of Transmittal, which together with the Offer to Purchase constitute the Offer), at a purchase price equal to 98% of the Funds net asset value per share determined as of September 6, 2017 at the close of ordinary trading on the New York Stock Exchange.
