The purpose of this Amendment is to correct the report filed on March 14, 2002, which failed to reflect the reporting person's exercise of an option to purchase 7,500 shares in Table I. The shares issued upon the exercise of the option were also omitted from the reporting person's subsequent Form 4 filings.
