The Reporting Person, as a participant in the Directors' Stock Accumulation Plan (the "DSAP"), will be entitled to receive a distribution in The Brink's Company ("Brink's") common stock in respect of all Brink's Units in the Reporting Person's account on a one-for-one basis following the Reporting Person's termination of service as a Non-Employee Director, in accordance with the terms of the DSAP.

(1) Brink's Units were credited to the Reporting Person's account under the DSAP as a result of an annual allocation, in accordance with the terms of the DSAP. The number of Brink's Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$22.50, which is the average trading price of Brink's common stock on June 1, 2010, calculated in accordance with the terms of the DSAP.

(2) Includes a total of 7.69 Brink's Units representing shares of Brink's common stock that were credited to the Reporting Person's account under the DSAP on March 1 and June 1, 2010 as a result of dividend payments, in accordance with the terms of the DSAP.
