- (2) Upon completion of the merger of Wesco with and into Merger Sub, each share of Wesco's common stock (other than shares owned by Berkshire or its subsidiaries) was converted into the right to receive an amount, either in cash or Berkshire Class B common stock, par value \$0.0033 per share, at the election of the shareholder, equal to \$385.00, calculated in accordance with the Merger Agreement.
